NatureSweet® Sweet Poppabilibites Sweepstakes

BY SUBMITTING AN ENTRY (as defined below) TO THE NATURESWEET SWEET POPPABILIBITES SWEEPSTAKES (the “Sweepstakes”), YOU AGREE TO BE BOUND BY THESE OFFICIAL RULES. NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN THIS SWEEPSTAKES, AND A PURCHASE OR PAYMENT WILL NOT INCREASE YOUR CHANCES OF WINNING. SWEEPSTAKES PERIOD: The total period in which the Sweepstakes will be run begins at 12:00:00 AM Central Time (“CT”) on July 20, 2022 and ends at 11:59:59 PM CT on September 18, 2022 (the “Total Sweepstakes Period”). The Total Sweepstakes Period is divided into nine (9) periods. The first eight periods (each a “Weekly Period”) are each a week in length, and each will serve as a separate Sweepstakes period for which a Weekly Period prize is available. The date and time that the first Entry for each Weekly Period will be accepted (the “Entry Start”) and the date and time that the last Entry for each Weekly Period will be accepted (the “Entry End”) is stated in Table 1 shown in Section 5 of these Official Rules. The desktop clock displayed on the homepage on a computer identified by Sponsor prior to commencement of the Total Sweepstakes Period shall be the official time keeping device for this Sweepstakes.

2. Entries received by NatureSweet via any of the methods described above are each referenced herein as an "Entry" (and collectively, as "Entries"). The person identified on a satisfactorily completed and submitted Entry will be considered the Entrant, subject to any other requirements imposed under these Rules. Submission of erroneous or incomplete information will void a submitted Entry.

During the Sweepstakes Period, Entrants may submit one (1) unique Entry per Entry Period. Once an Entrant submits a Sweepstakes entry during a specific Entry Period, he/she/they may **not** submit another Sweepstakes entry during the same Entry Period, regardless of what social media platform or other entry method is used. You acknowledge and agree that Sponsor may receive many Entries in connection with this Sweepstakes, and that your Entry may be similar or identical (in whole or in part) in theme, idea, format or other respects to other Entries received by Sponsor in connection with this Sweepstakes or otherwise provided to Sponsor, or to original works conceived or created by Sponsor. You waive any and all claims you have or may have, now or in the future, that any Entry and/or other works accepted, reviewed, created and/or used by or on behalf of Sponsor are similar or identical (in whole or in part) to your Entry. 5. DETERMINATION OF WINNERS:

On or around the “Entry End” date indicated for a Weekly Period in Table 1 below, eight (8) Entries will be randomly drawn by or on behalf of Sponsor from all eligible Entries received during that Weekly Period. Each of such eight (8) Entries shall be deemed a “Weekly Prize Winning Entry” upon verification by or on behalf of Sponsor that such Entry and corresponding Entrant satisfy all eligibility requirements stated in, and are otherwise in compliance with, these Official Rules.

All entries received during the Total Sweepstakes Period shall be automatically entered into a “Grand Prize Drawing”. One (1) Entry shall then be randomly drawn by or on behalf of Sponsor from all aggregated Entries.
